- Minimum Deposit of 30% of total amount due, or \$300 (whichever is greater), is required to bind terms (deposits are non-refundable).
- Standard 700 Watt, two Speaker Sound System, and two 250 Watt Lighting System included unless otherwise noted above.
- Hot meals are required to be provided for all DJ Staff during the event. = \_\_\_\_\_
- Parties entering into this contract are permanently bound to fulfill the obligations by this agreement unless both parties mutually agree to leave the agreement and its responsibilities.
- Cancellation must be in writing no less than 30 days prior to event date described herein. If cancellation is made 30 days or less of the event date described herein, full balance stated above is immediately due.
- No out-of-state checks accepted. Out-of-state Payment must be made with Bank Cashiers Check or Money Order.
- In the event of non-payment, the DJ retains the right to attempt collection through legal means. The client will be held responsible for all court fees, legal fees and collection costs incurred by the DJ. There will also be a \$10 service fee for each collection notice that "Afterburn Productions" sends to the client due to non-payment.
- \$39 service fee for any returned checks written to Christian Rasmussen or "Cash"
- Additional charges may apply for special moving for set-up or breakdown of equipment due to stairs, elevators or long distances between Loading and Party Areas.
- Client is responsible for verifying that there is sufficient power at venue to power the above listed equipment = \_\_\_\_\_ Amps. If venue can't provide sufficient power, Generators are available for rental at additional cost.
- If outside event, tent required for 10% or more chance of precipitation (Tent is available for a minimal fee. Determined by <http://www.weather.gov>)
